WHITE MOUNTAIN LAKES UNIT NO. 1 AMENDMENT TO DECLARATION OF ESTABLISHMENT OF CONDITIONS AND RESTRICTIONS

KNOW ALL MEN BY THESE PRESENTS:

That WIEREAS, PROENIX TITLE & TRUST COMPANY, an Arizona Corporation, as Trustee under Trust No. 6271, established conditions and restrictions affecting the real property hereinafter described, and

WHEREAS, by Substitution of Trust Agreement, STEWART TITLE AND TRUST OF TUCSON, an Arizona Corporation, as Trustee under Trust No. 0314, was substituted in the name, place and stead of said Phoenix Title & Trust Company; and

WHEREAS, by Substitution of Trustee Agreement, TRANSAMERICA TITLE INSURANCE CO.. an Arizona Corporation, as Trustee under Trust No. 5337, hereinafter referred to as TRUSTEE, was substituted as Trustee in the name, place and stead of said Stewart Title and Trust of Tucson; and

WHEREAS, FRANK PLUMMER, a single man, is the owner of that certain real property situate in the County of Navajo and State of Arizona, described as follows, to-wit:

Lots 19 and 20 in Block 16 of White Mountain Lakes, Unit No. 1, a Subdivision of Navajo County, Arizona, according to the map thereof of record in the office of the Navajo County Pacorder in Bock 8 of Maps at pages 9-10-11;

NOW. THEREFORE, in consideration of the mutual covenants herein contained, the parties hereto agree that Article II of said Declaration of Conditions and Restrictions, dated the 16th day of June, 1964, and recorded in the office of the Navajo County Recorder in Book 203 at pages 448, etc., is hereby amended as follows:

II. USES PERMITTED.

The above described lots may be used for the following described uses:

Mobile homes permitted on Lots 19 and 20, in Block 16, Unit 1.

One large trailer used for permanent use, and one small guest trailer permissed on each lot.

The placing of any trailer under 400 square feet must be approved by the White Mountain Lakes Architectural Committee.

In all other respects, except as hereinabove set forth, the Declaration of Establishment of Conditions and Restrictions
